

AAFES Merchandising Directorate Reorganizes PAR Team

• DALLAS

The Army & Air Force Exchange Service (AAFES) Merchandising Directorate (MD) reorganized its Planning, Allocation and Replenishment (PAR) team over a four-month period earlier this year, with the goal of serving Exchange clientele better.

According to Eric Boen, MD PAR vice president (VP), the reorganization of PAR — which was effectively completed on the last day of summer, Sept. 21 — “is an effort to better align our structure with current best practices in industry, by focusing efforts into a single discipline or center of excellence (CoE) that allows associates to establish processes and expertise within one of three areas: ‘Planning,’ ‘Allocation,’ or ‘Replenishment.’”

“Establishing consistent, long-term, and sustainable processes positions PAR to better manage the ongoing and different seasonal trends of the extensive breadth of categories and retail channels sustained by our supply chain.”

BROAD STROKES

Boen said that among the “broad strokes” of the reorganization, managers and associates “have transitioned from a category focus to a discipline-based focus where best practices can be established and propagated amongst team members within the same discipline, be it Planning, Allocation, or Replenishment.”

In PAR, Boen — who had previously served as

PAR director of the Specialty Store-Consumables Division, an entity which has since been reimagined into the Convenience Channel Division — said he was “appointed into” the “recreated” VP of MD PAR position.

Further personnel changes included Martha Robuck, who transitioned from her role as director of PAR Hardlines to director of Planning; Shirley Strano, who transitioned from director of PAR Softlines to director of Allocation; and Kim Worrell, who transitioned from director of PAR Consumables to director of Replenishment.

Based on these personnel transitions, Boen noted, “There is a fundamental shift in the communication structure; however, service levels and overarching support is expected to improve over time.”

PAR STAFF INPUT

Boen said that the new PAR directors and the PAR manager staff had much input into the successful transition of PAR from a category-based structure to a discipline-focused team effort.

“This could not have happened without the hard work and dedication of the PAR manager staff,” Boen said, including Todd Anderson; Kevin Brett; Diane Frye; Genny Garcia; Ed Madden; Angie Porter; Amy Ralston; Linda Wiley; and Alan Sekikawa, “as well as its directors,” Martha Robuck, Shirley Strano and Kim Worrell.

Although the reorganization was completed on the last day of summer, as of mid-October, Boen noted, “We are in an ongoing evaluation phase to ensure validity and effectiveness of the new structure.”
